Both smarting from semifinal losses in Milwaukee, Alvarado and Bike were fighting for this year's title of "most-feared." Fast and furious, they battled point for point from the start. There wasn't the time nor the luxury of feeling the other player out. Finding the groove with the wicked Z-serve to the left, Bike took a slight lead. Realizing the momentum was shifting to his younger opponent, Alvarado went for broke and tried to pick a few off out of the air while looking into the

dark right side wall of glass. It was the type of last-ditch effort that has earned Alvarado the nickname of "Houdini." There was no escape this time and Bike earned a 21-18 decision.

You would have been laughed at if you had correctly predicted the second-game outcome. A determined Alvarado took to the court after the five-minute respite but Bike was in another world. Pumping his fist with each unretrievable blast, Bike never looked back. The big lefty overpowered the game's all-time best by sizzling the small blue sphere as if it were a BB. There was more first-round fireworks as qualifier Charlie Kalil held an 8-6 tie-breaker lead over No. 1 seed Monreal before Poncho managed the win. In the same bracket, qualifier Roberto Meneses of Vancouver pushed Vern Roberts to three games.
